Thank you for attending the Public Information Open House (PIOH) for the proposed Interstate 285 Eastside Express Lanes project to construct express lanes on an approximately 10.1-mile section of Interstate 285 (I-285) from just south of State Route (SR) 260/Glenwood Road to just north of the Henderson Road/I-285 overpass in DeKalb County, PI Number 0013914.

Our goal is two-fold: 1) to provide you with information on the proposed project and 2) to provide an opportunity for you to give us your comments on the proposed project. In this handout package, you will find a description of the project, a location map, and a comment card.

As you enter the room, please take a look at the project display. Georgia Department of Transportation (GDOT) representatives, wearing nametags, are available to discuss the project and answer your questions. There will be no formal presentation.

We hope you will take the opportunity to tell the GDOT what you think. Listed below are several ways to comment on the project. Your comments are important to us and, should you provide comments by one of the methods noted below, we will respond to you in writing usually within 30 days of the close of the comment period. All comments will become part of the project's official record.

While you are attending the open house, you can provide your comments today by filling out the comment card provided with this handout and dropping it in the comment box, or you may choose to provide your verbal comments to the court reporter who will transcribe your comments.

Why We Are Here: There is a need for the proposed I-285 Eastside Express Lanes (ELs) project to provide reliable travel times for drivers and transit users, improve connections between regional destinations through priced, express lanes that integrate with the Georgia Express Lanes, and to accelerate project delivery in compliance with the Transportation Funding Act (TFA) of 2015 legislative mandate.

The I-285 Eastside ELs project is one of 11 initial Major Mobility Investment Program, or MMIP, projects advancing across the state in an effort to yield a significant reduction in congestion along key freight and passenger corridors. The projects would create additional capacity, improve the movement of freight, provide operational improvements and efficiencies, enhance safety, and decrease travel times.



Project Description: The proposed project would construct approximately 10.1 miles of new buffer-separated express lanes along I-285 from just south of SR 260/Glenwood Road to just north of the Henderson Road/I-285 overpass. Improvements include construction of the new express lanes, three (3) new structures overpassing the US-78/Stone Mountain Freeway at I-285 Interchange, minor ramp modifications at service interchanges, and reconstruction of several overpass structures. The project location is shown on the following page.

The project proposes to add one (1) priced EL in each direction along I-285. The existing inside general purpose (GP) lane would be converted to an 11-foot EL which would be separated from the GP lanes by a 2-foot striped buffer. To maintain the existing number of GP lanes, the existing outside shoulder would be converted to a GP lane and a new 14-foot outside shoulder would be constructed. The proposed typical section in each direction would consist of 6.75-foot inside shoulder; one (1), 11-foot EL; a 2-foot striped buffer; one (1), 11-foot GP lane; three (3), 12-foot GP lanes; and the 14-foot outside shoulder, comprised of the 12-foot paved and 2-foot grassed outside shoulder. The preferred minimum right-of-way width to accommodate this typical section is 208 feet.

The proposed express lanes would be variably priced to attain reliable trip times and would be free of charge to transit providers.
